A joint effort of the Cincinnati Bar Association and the Legal Aid Society of Greater Cincinnati. The Volunteer Lawyer Project was created in response to a steadily growing gap between the number of requests for services from low-income citizens and Legal Aid's ability to provide these services. Today, the Volunteer Lawyers Project serves as pro bono arm of the Cincinnati and Butler, Clermont, Clinton and Warren County Bar Associations. The VLP allows attorneys to represent low-income persons whose cases have merit but which might otherwise be lost due to their inability to pay for counsel and the resulting inadequate self-representation.
