Law and Literature: This course will consider the intersection of law and literature, challenging students to examine fundamental legal principles through the lens of fiction and drama. Readings will include works by Shakespeare, Orwell, Camus, Sophocles, Agatha Christie, Ian McEwan, Ursula Le Guin, Euripides, Asimov, Melville, and others. Discussion will address revenge; justice; morality; equity; civil disobedience; religion; fairness; advocacy; and anarchy. Readings will generally be of moderate length, and estimated time required for out-of-class reading and preparation should not exceed 4-5 hours per week. The class is limited to 15 students and will be conducted as a seminar; students will be expected to arrive in class prepared to participate actively in discussion.

Lunsford Seminar I: Will not follow a weekly class schedule. Class sessions will be announced in advance of the beginning of the course.

Tax – VITA Pro Bono: The Volunteer Income Tax Assistance (VITA) project is a program staffed with volunteers who assist low-income taxpayers and low-income households in our community e-file their federal and state tax returns. Assisting taxpayers file their returns enables them to access major anti-poverty programs that are delivered via our tax system with the tax return as the delivery tool. Most taxpayers assisted will receive significant tax refunds, a welcome financial resource those in poverty need to meet immediate bills or other living needs.

In participating VITA, students will have the opportunity to interact with taxpayers from different economic and cultural walks of life and racial and ethnic backgrounds, an experience that will be fulfilling and broadening.

The VITA program runs during the tax filing season, generally from late January until April 15 on Saturdays from 10 am to 1 pm; and on Monday and Tuesday afternoons. Students can volunteer at one site or at a combination of sites.

For students, VITA is a live-client experience and law in action: interviewing, fact gathering, legal decision-making. While participating in VITA, students will (a) learn to develop analytical and transactional skills while assisting taxpayers file their returns, (b) learn to work with clients, and (c) learn to work collaboratively with fellow tax return preparers and site manager(s) at the field placement site.

The VITA experience will help students sharpen their professional skills in fact development while dealing with clients in an ethical and courteous manner in a team professional setting.

As students in a public institution, VITA offers students the opportunity of not only enhancing their legal education but also of engaging in public service assisting taxpayers in our community.

For students who are particularly interested in family law, children's welfare, and approaches to tackling poverty, the externship offers an opportunity to see how those areas are addressed in our tax system in the form of direct cash transfers via tax credits as an alternative to in-kind transfers as a means for tackling poverty related issues. VITA will give students the opportunity to experience the practical side of a (tax) public policy program aimed at delivering low-wage, family and other anti-poverty support programs.

The Chase VITA program dates back to the 1988 filing season and has operated continuously since then. During that time, the Chase VITA program has assisted well over 10,000 taxpayers in our community file for about \$25 million in tax refunds. And during that time, about 250 Chase students have volunteered in this project.

Students can participate in VITA: (i) for 1-credit hour of externship course credit, (ii) for pro bono graduation recognition or (iii) just volunteer.

To be eligible to participate in VITA, students will need to certify as tax return preparers using a test administered by the IRS (see Pub 6744). Students can prepare for the certification on their own using the training tools on the IRS VITA website or they can prepare by taking the 1-credit pass/fail online course, Tax – Work, Family, Poverty offered by Prof. Nacev in January before the start of the spring semester.

Tax – VITA Externship: The Tax – VITA Externship course is a 1-credit hour, pass/fail experiential course during which students prepare federal and state tax returns during the 2027 tax filing season for low-income taxpayers in a Volunteer Income Tax Assistance (VITA) field placement site in Covington, KY. To earn the course credit, students will need to put in 50 hours of tax return preparation assistance. To be eligible to participate in the course, students will need to certify as tax return preparers using a test administered by the IRS. Students can prepare for the certification on their own using the training tools on the IRS VITA website or by taking the 1-credit pass/fail online course offered in January before the start of the spring semester by Prof. Nacev.

The externship will help students sharpen their professional skills in fact development while dealing with clients in an ethical and courteous manner in a team professional setting. In the tax externship, students will (a) learn to develop analytical and transactional skills while assisting taxpayers file their returns, (b) learn to work with clients, and (c) learn to work collaboratively with fellow tax return preparers and site manager(s) at the field placement site.

In participating in the tax externship, students will have the opportunity to interact with taxpayers from different economic and cultural walks of life and racial and ethnic backgrounds, an experience that will be fulfilling and broadening.

In a broader learning framework, the tax externship will give students hands-on technical experience in integrating the tax law dealing with the taxation of low-income taxpayers and low-income households with the process of delivering economic assistance to those in poverty via the filing of a federal and state income tax return. For students who are particularly interested in family law, children's welfare, and approaches to tackling poverty, the externship offers an opportunity to see how those areas are addressed in our tax system in the form of direct cash transfers via tax credits as an alternative to in-kind transfers as a means for tackling poverty related issues. In completing the externship, students will experience the practical side of a tax public policy program aimed at delivering low-wage, family and other anti-poverty support programs.

As students in a public institution, the tax externship, in addition, offers students the opportunity of not only enhancing their legal education but also of engaging in public service assisting taxpayers in our community.
